Effective March 12, 2021 at 5pm, Maryland and Frederick County updated and lifted some of the COVID-19 restrictions that were in effect. Therefore, we are making changes to our safety protocols immediately.

- No longer restricting spectators inside the facility. Physical distancing will continue to be enforced...

- Masks are required for **ALL** athletes and spectators over the age of 5, unless they have a documentable medical condition
 - This means **masks must be worn AT ALL TIMES - NO EXCEPTIONS. If you refuse to wear a mask, you will be asked to leave the premises.**
- Everyone must have their temperatures taken upon entry to the facility. For your convenience, we have automated thermometers mounted at the main entrance of the facility.
- Only show up no more than 10 minutes prior to your scheduled field time. And please follow arrows and markings on floor to maximize social distancing and flow of patrons.
- PHYSICALLY DISTANCE... Distancing is required in all common areas of the facility. Please try to refrain from congregating in the lobby of FISC. As always, The Upper Deck Too is open for food and drinks before, during, or after games/programs
- STAY HOME if you feel sick or have any symptoms, absolutely no spitting and **DO NOT FORGET TO WASH YOUR HANDS!**

IMPORTANT NOTE - WE ARE ALL IN THIS TOGETHER

- If at any point you see an area of improvement, you feel unsafe, or you feel that FISC is not doing it's absolute best to comply with the regulations to stop the spread of COVID, we kindly ask that you do the noble thing and **come to a FISC staff member first to express your concerns.**
- Please do not take photos of people in FISC as this infringes on their privacy and it is certainly not the quickest way to resolve issues. The best thing anyone can do is to express concerns directly to the people who can immediately impact and solve the issue at hand.
- We know you understand this and are a supportive part of the FISC family. Thank you so much for helping us stay open. We know the new policies are not ideal for anyone, but we **MUST** enforce them, **IT IS SIMPLY THE RIGHT THING TO DO FOR THE SAFETY, HEALTH AND WELL BEING OF US ALL.**

IF YOU TEST POSITIVE:

1. If you or your guest at the facility tests positive for COVID-19 or comes in direct contact with someone who has been positively diagnosed within the previous 14 days, is required to report diagnosis or exposure to FISC. All reports will remain anonymous and other players and staff that were potentially in contact with that person/player will be notified
2. To report a positive COVID-19 test to FISC, please text POSITIVE to 522-36 and complete brief form.
